

RESOLUTION NO. 1661

**A RESOLUTION PROVIDING FOR AN ANNUAL BUSINESS REGISTRATION FEE
UPON TRADES, PROFESSIONS, OCCUPATIONS, BUSINESSES AND SHOPS
CONDUCTING BUSINESS IN THE CITY OF TILLAMOOK
IN ACCORDANCE WITH ORDINANCE 1288**

WHEREAS, the City of Tillamook has enacted Ordinance 1288, an annual business registration upon trades, professions, occupations, businesses and shops conducting business in the City Limits of Tillamook; and

WHEREAS, fees and fines for Ordinance 1288 are to be set by resolution.

NOW, THEREFORE, BE IT RESOLVED, by the Tillamook City Council that the annual fee schedule for a business registration with the City of Tillamook is as follows:

Section 1:

LICENSING FEES

Section 2:

Employers - Owner or manager shall be counted with respect to the base fee. In case of multiple owners, any owner, operator, sales person, agent or worker whether paid by salary, bonus, commission, piecework or hourly wage and associated with or working for any commercial, professional, fraternal or public establishment within the City of Tillamook shall be counted with respect to the base fee.

Independent Contractors - Each individual with a state license affiliated with a business shall count as one employee.

Part-time Employees - Employee working over 24 hours per week on average shall be counted as one (1) full time employee; every two (2) part-time employees shall be counted as one (1) full-time employee regardless of hours worked.

Section 3:

Annual shall mean July 1st to June 30th.

Section 4:


Violation of any section of Ordinance No. 1288 shall result in a fine not to exceed \$250.00. Upon conviction of any violation of this ordinance, the court shall also order the defendant to pay any cost, disbursement or fee due as authorized by this ordinance or as amended.

Each day or distinct time period of a violation as described in this ordinance, shall be considered a separate violation, subject to a separate penalty as described in this ordinance and by resolution.

Section 5:


The effective date of this resolution shall be upon approval by the City Council.
