## TURA BENCH PROGRAM

The TURA Bench Program allows individuals or businesses to sponsor or advertise on select benches in the City of Tillamook for a period of 10 years for sponsorship or annual advertisement and have a plaque placed on a city bench.

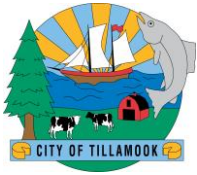
**SPONSORSHIP:** The cost to sponsor a memorial or honorarium bench for 10 years is \$500.00, which includes a 4” x 6” engraved plaque and placement. The cost for the plaque is included in the sponsorship amount. The sponsor will work with staff regarding the choice of bench location, engraved wording, and placement of the plaque. The sponsor will supply plaque language to staff and staff will submit to the engraver when approved. Please be advised that plaque wording is not limited, but more wording will result in smaller print. Once the inscribed plaque is completed the sponsor will be notified for coordination of installation with the City Public Works Department. After the 10-year period, the City will attempt to return the plaque to the sponsor.

**ADVERTISEMENT:** The cost to advertise annually on a bench is \$200.00. The maximum size of engraved advertisement plaques is 4” x 12”. Once wording and graphics have been agreed upon, the advertiser will deal directly with the engraver for plaque costs. Plaque placement costs will be billed separately on an annual basis. The advertisement plaque will remain until TURA is notified of cancellation or changes to annual advertising criteria or fees.

Please complete and return the TURA Bench Program Application with a check or money order made payable to the Tillamook Urban Renewal Agency. We suggest that you check with your tax advisor regarding potential tax advantages.
